Know your numbers

A “Know Your Numbers” health camp was organized by the Chair Rtn. Rakesh Sinhal and his Preventive and Curative Health Committee for Rotarians and their families on 4th July 2021 at Rotary Centre. The Chair had organized a team of lab technicians from the Shree Tibet Diagnostics Centre to do the needful i.e., to measure the height, weight, blood pressure, blood sugar, haemoglobin, BMI, pulse and oxygen saturation. ECGs were also measured. To sum up, the basic parameters of routine preventive health check up were carried out. The technicians worked in tandem with the Community service Chair Rtn. Dr. S Zimba and the Health Committee Co-Chair Rtn. Dr. Gaurav Chettri. The President expressed his gratitude on behalf of the RC- Kalimpong to the lab technicians who were facilitated by khadas. Community service Chair Rtn. Dr. S Zimba gave a succinct talk on health matters. He explained the significance of the “numbers” and the importance they played in maintaining good health. The Health Committee Chair Rtn. Rakesh Sinhal also spoke and emphasized the necessity of following up especially by those whose numbers did not certify a clean bill of health. He reported that a total of 32 persons had been reviewed for preventive and curative health in this camp. He also mentioned that his team would be holding such a camp for the community at large in near future.



Agro Vet Camp

An Agro Vet Camp was organized on 14th July 2021 at RCC Ecchey, a remote village approximately 15 Kms from Kalimpong.

Rotarians and Annes of RC-Kalimpong interacted with the RCC members and their families and also participated in transplanting of paddy saplings.

The camp strengthened the relationship with RCC Ecchey and formed a bond between their families and our members.



Blood Donation Camp

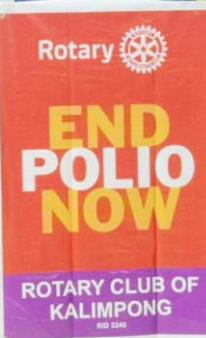
World Polio Day

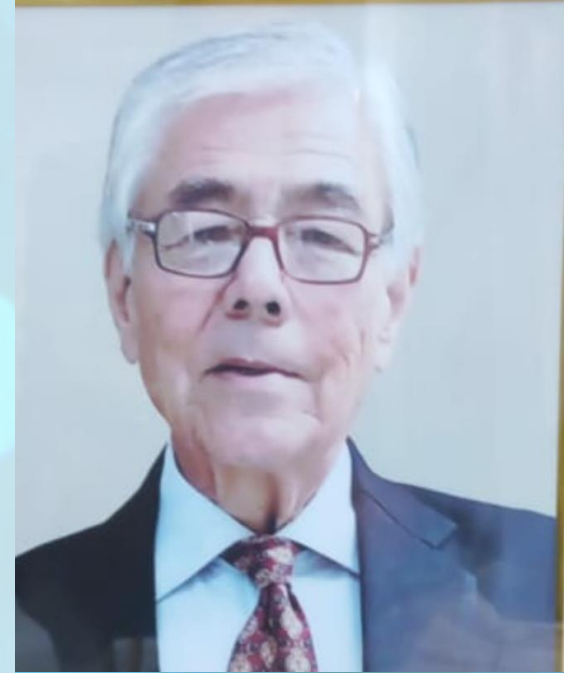

Demise of PP Rtn. Ganesh

The sudden and sad demise of P.P. Rtn. Ganesh Uncle brought the curtains down of an era of class, dignity and decorum in Rotary. Ganesh Uncle, as many of us used to call him, was a colossal figure in Rotary Kalimpong, especially in its formative years of the 90s. He strode the Rotary stage with dignity, poise and elan. As the second President of Rotary Club of Kalimpong, he steered the Club infusing dynamism and foresight - playing a pivotal role in shaping the club as it is today. Many new members may not have had the opportunity to have known him. He went by the Rotary Classification "Orchid Breeder" and was born on 27 May 1941. He did his schooling in St. Augustine's School and Dr. Graham's Homes and joined St. Joseph's College, North Point. Ganesh Uncle took the leadership mantle when the world was on the throes of an imminent information and internet revolution. He was quick to foresee the power and control it had in networking and quickly harnessed it to make our Club at par with any technologically advanced Clubs in the world. He was behind the success story of the many Matching Grant Projects under TRF - the Bhagey Sangsey Drinking Water Project, Computer Installations at Pranami Balika Vidya Mandir, supply of Medical Equipment at Steel Memorial Hospital Dr. Graham's Homes, among others. He was a man who lived far ahead of his times. He used the same cutting-edge technology in propagation and marketing of the orchids that he used to breed. He was instrumental in the construction of the Ground Floor of the Rotary Centre. A cash strapped Club then, he motivated many to donate and contributed large sums from his own resources. He was a mentor and guide to so many Rotarians including me and saw him as a role model. An avid photographer and a voracious reader, he had a large fan following in Kalimpong. As we bid a teary Adieu, please be rest assured that the legacy you created and left behind will be carried forward as relentlessly as you did.




Bylaws of Rotary Club of Kalimpong

Bylaws of Rotary Club of Kalimpong 2020-21

Bylaws of the Rotary Club of Kalimpong

Club bylaws supplement the Standard Rotary Club Constitution with common club practices. The bylaws in this document have been adopted vide 5th Board Meeting held on 14 Nov 2021 and confirm that they are not in conflict with the RI Constitution and Bylaws, the Standard Rotary Club Constitution (except where permitted), and the Rotary Code of Policies and are binding for the members of the club.

Article 1 Definitions

1. Board: The board of directors of this club.
2. Director: A director on this club's board.
3. Member: A member, other than an honorary member, of this club.
4. Quorum: The minimum number of participants who must be present when a Vote is taken: one-third of the club's members for club decisions and a majority of the directors for club board decisions.
5. RI: Rotary International.
6. Year: The 12-month period beginning 1 July.

One-third (1/3rd) of the Club members will make a quorum to vote for club decisions and Majority of the Directors to vote for club Board decisions. Chairs, Vice Chairs or other members as specifically mentioned in these bylaws, will have/not have voting powers in the Board.

Article 2 Board

The governing body of this club is its board of directors, consisting of, at a minimum, the president, immediate past president, president-elect, secretary, and treasurer. The following office bearers will form the Board: -

1. President
2. Immediate Past President
3. President Elect
4. Vice President
5. Secretary
6. Joint Secretary (No voting power)
7. Treasurer
8. Co Treasurer (No voting power)
9. Sergeant At Arms
10. Editor
11. President Elect Nominee (No voting power)
12. Club Trainer (No voting power)

13. Chair Club Administration
 - (a) Club Service Director
 - (b) Digital Library (No voting power)
 - (c) Website (No voting power)

Article 3 Elections and Terms of Office

Section 1 —In every first week of November the club shall constitute a Nominating Committee comprising of such number of Past Presidents and President Elect as may be decided by the regular meeting of the club for nomination of new Board of Directors for the next Rotary year. The Immediate Past President shall convene and chair the Nominating Committee meeting and shall make nomination of the Board of Directors and shall confirm the nomination of the Board after due consultation and on consent of the each proposed member of the Board. In case more than one names are listed, nomination supported by majority members of the NC shall be declared nominated. After having finalized the nomination and confirmation from each nominee to the Board, the Nominating Committee Chairs shall place the same before the regular meeting for declaration of the names of the new Board of Directors. Each Chair will have an understudy for succession plan and continuity.

The candidate for President Elect in such nominations shall be the President Elect Nominee and serve as a Director for the year commencing on the first day of July next following the election, and shall assume office as President on 1 July immediately following that year. The President Elect Nominee shall take the title of President Elect on 1 July in the year prior to taking office as President.

Section 2 - Election of the Board will be by consensus.

Section 3—If any officer or board member vacates their position, the remaining members of the board will appoint a replacement.

Section 4—If any officer-elect or director-elect vacates a position, the remaining members of the board-elect will appoint a replacement.

Section 5—The term of office of Literacy Director & Foundation Chair will be three years. Term of office of other office bearers will be will be one year.

Article 4 Duties of the Officers

Section 1 The president presides at club and board meetings

Section 2 The immediate past president serves as a director on the club board.
The president-elect prepares for his or her year in office and serves as a

Section 3 Director

The vice president presides at club and board meetings when the president is

Section 4 absent

Section 5 A director attends club and board meetings.

Section 6 The secretary keeps membership and attendance records.

Section 7 The treasurer oversees all funds and provides an accounting of them

Section 8 The sergeant-at-arms maintains order in club meetings

See Rotary club leader manuals for details on the roles and responsibilities of club officers.

Article 5 Meetings

Section 1 —An annual meeting of this club is held in the first week of November every year but no later than 31 December to elect the officers and directors who will serve for the next Rotary year.

Section 2 —This club meets as follows : Every THURSDAY at 5 p.m. physically or virtually, if need be. Reasonable notice of any change or cancellation of the regular meeting will be given to all club members. The Agenda for the meeting is to be circulated at least a day in advance of the Regular Meeting.

Section 3 —Board meetings are held each month, physically or virtually. Special meetings of the board are called with reasonable notice by the president or upon the request of two directors.

Section 4 - Club Assemblies will be held as per the following schedule:-First Assembly -

In July , Immediately after taking over by the new Board.

Second Assembly - Before the District Training Assembly.

Third Assembly - Two weeks before visit of DG.

Fourth Assembly - After the visit of DG.

Fifth Assembly - In April.

Sixth Assembly - Before closure of Rotary year to give finishing touches.

Article 6 Dues

Annual club dues are Rs 24,000/- (Indian Rupees Twenty Four Thousand only). They are paid as follows :

First Semi-Annual latest by 15th June.

Second Semi-Annual latest by 15th December of each Rotary year.

Annual club dues include RI per capita dues, subscriptions to an official magazine, district per capita dues, club fees, and any other Rotary or district per capita assessment. Admission Fee for New Member is Rs. 10,000/- (Indian Rupees Ten Thousand only).

Nonpayment of Semi-Annual dues within the stipulated time, i.e. First Semi by 15th June and Second Semi by 15th December of every Rotary Year will result in automatic deletion/removal of membership UNLESS a written application is received by the President/Treasurer from a member explaining his problem. In any case, failing to pay semi-annual dues within 30th June or 31st December, as the case may be, the name of defaulting member will stand deleted automatically from the membership list.

Article 7 Method of Voting

The business of this club is conducted by voice vote or a show of hands except in the election of officers and directors, which is conducted by consensus. The board may also provide a ballot for a vote on some resolutions.

Article 8 Committees

Section 1 —Club Committees coordinates their efforts in order to achieve the club's annual and long term goals. This club will have the following committees: -

1. Club Administration
2. Membership
3. Public Relations
4. Rotary Foundation
5. Service Projects
6. Literacy Mission
7. Sanitation
8. Water
9. Disaster Mission
10. Environment
11. Health - preventive& curative,
12. CSR

Additional Committees include Club Service, Vocational Service, Community Service and International Service.

Section 2—The IPP, PRESIDENT, and PRESIDENT ELECT is an ex officio member of all committees.

Section 3—Each committee's chair is responsible for the regular meetings and activities of the committee, supervises and coordinates its work, and reports to the board on all committee activities.

Article 9 Finances

Section 1 —Before each fiscal year starts, the board prepares an annual budget of estimated income and expenditures.

Section 2 — The treasurer deposits club funds in a financial institution or institutions designated by the board, divided into two accounts: one for club operations and one for service projects.

Section 3 —Bills are paid by the treasurer or another authorized officer and approved by two other officers or directors.

Section 4 — A qualified person conducts a thorough annual review of all financial transactions.

Section 5 —Club members will receive an annual financial statement of the club. Monthly expenditure statement will be reported during each monthly Board Meeting. A mid-year financial report, with current and previous year income and expenses, is presented at the annual meeting.

Section 6 - Chairman of the RHSP Trust will be ex-officio member of the Board. However, there is no requirement of including the rules and regulation of the Trust in the Club Bylaws. These are available in the Club's website for all members to make themselves acquainted with. The Board of Trustees of KRHSPT will function as per Duties and powers enshrined in the Constitution of the Board of Trust Deed.

Section 7— The fiscal year is from 1 July to 30 June.

Article 10 Method of Electing Members

Section 1 —A member proposes a candidate for membership to the board and/or the membership committee, or another club proposes one of its transferring or former members.

Section 2 — The board approves or rejects the candidate's membership within 30 days and notifies the proposing member of its decision.

Section 3— If the board approves the candidate's membership, the prospective member is invited to join the club.

Section 4 - If single member has any objection to a new member, than he has to give his objection in writing to the President within ten days. If there is objection to a new member by two or more members, his proposal is automatically rejected.

Article 11 Amendments

These bylaws may be amended at any regular club meeting. Changing the club bylaws requires sending written notice to each member 21 days before the meeting, having a quorum present for the vote, and having two-thirds of the votes support the change. Changes to these bylaws must be consistent with the Standard Rotary Club Constitution, the RI Constitution and Bylaws, and the Rotary Code of Policies.
